sums (whether they know it or not) on material that is not connected with fundamental learning. Greater transparency will help parents make the best decisions for their children's education. LaRock added, "Focusing on core academics and vocational training are priorities all families can agree on."

Parents have the right to instill and nurture values and beliefs in their own children and make decisions concerning their children's development in accordance with their customs, faith, and family culture. School policies must ensure that parents are in charge.

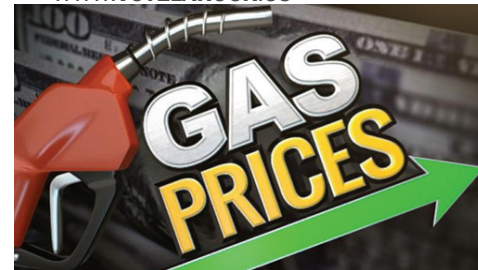

reliability. A realistic approach to clean energy will help us avoid becoming like California - at constant risk of rolling blackouts and scrambling to just keep the lights on. ## BROADBAND SERVICE COMING SOON TO HOMES

After many years of effort, we are finally getting close to having universal broadband access for all of the constituents I serve. Through public-private partnerships, fiber-to-home broadband projects are moving forward to serve all residents in Loudoun, Clarke, Frederick, Warren, and

Shenandoah Counties. A combination of state grants approved in December 2021, local government contributions, broadband provider buy-in, and funding and pole access from electricity providers is making this long-term effort a reality.

Final planning is underway, materials are being secured, and construction is start-

ing. This is a big project and is required to be completed by July 22, 2025.

## PERSISTENCE PAYS WITH PROGRESS ON INTERSTATE-81

The I-81 Corridor has been over-capacity for decades. I and other I-81 corridor legislators ordered a data-driven study of I-81 which identified \$4.2 billion in potential projects. The Virginia General Assembly in 2019 secured \$2 billion in funding for the pri-

ority projects identified by the study.

The I-81 Corridor Improvement Program now includes 64 fully-funded operational and capital improvement projects that are expected to result in 450 fewer crashes and 6 million fewer hours of delay each year.

In our area, merge lane extensions and curve improvements are completed, while

more complex projects including adding a third lane for four miles southbound from the I-66 merge in Shenandoah County, and in both directions between exits 313 and 317 in Winchester, are funded and in early design stages.
