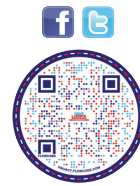

- Composed and sent numerous letters to the Virginia Health Commissioner arguing that vaccines were not fully approved and could not be mandated and demanded he reverse his ban on hydroxychloroquine use.
- Sued Northam over unconstitutional and improperly enacted COVID regulations.
- Championed School Choice with bills being beat down by Democrat Gov. McAuliffe and Lt. Gov. Northam.
- Composed and sent a letter from Delegates and pastors to Northam informing him churches were OPENING IN DEFIANCE OF HIS LOCKDOWN ORDER. Northam backed down and rescinded the church ban shortly after.
- Sued AG Herring and won, forcing him to provide an important AG opinion on whether Virginia law provided special protections for sexual orientation or gender identity.
- Stood with healthcare workers against Covid-related discrimination, leading to an Attorney General warning letter to Inova Hospitals.
- Dave's bill - Sage's Law HB 2432, gained nationwide attention in the Parents Rights movement for helping protect kids and exposing the harms of the hypersexualization of kids; harms like sterilization, body mutilation, sex trafficking, depression and suicide.

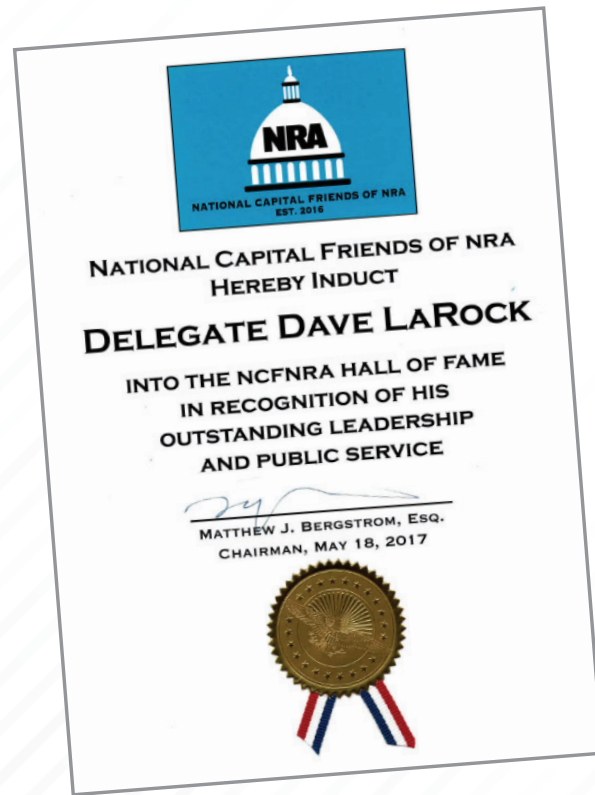
